The undersigned Band, Artist, Recording Company, Licensee, Copyright Holder(s) of the submitted material herein referred to as "Owner", hereby grants, licenses and assigns to SCOR and its designated representatives the following authorizations:

1. "Owner" hereby expressly grants to SCOR a non-exclusive worldwide license to digitally transmit via the Internet, on an interactive or non-interactive basis, the sound/video recordings, and the musical composition(s) embodied therein, as specified in Schedule A of this Broadcast Release Agreement.
2. "Owner" hereby expressly grants to SCOR a non-exclusive worldwide license to digitally transmit via the Internet, as part of an interactive or non-interactive, non-subscription music program or channel, selections from the sound/video recordings, and the musical compositions embodied therein, as specified in Schedule A of this Broadcast Release Agreement.
3. "Owner" hereby expressly authorizes SCOR to copy - to the SCOR servers such copies of each of the identified sound recordings as are reasonably necessary to facilitate the efficient transmission of the- sound recordings from initiation through to the listener.
4. Neither SCOR nor the "Owner" shall pay to the other any compensation with respect to the transmissions and reproductions authorized herein.
5. "Owner" represents and warrants to SCOR:
 - a. the "Owner" has the right to authorize SCOR to reproduce, publicly perform and distribute in MP3 or other similar format by an interactive service, copies of

- the listed sound recordings and the musical compositions embodied therein;
- b. the "Owner" has the right and authority to license all rights granted herein, including, but not limited to, copyright and trademark rights;
- c. the undersigned has been authorized to execute this Broadcast Release Agreement on behalf of the "Owner".

6. "Owner" hereby agrees to indemnify and hold SCOR, its officers, directors, employees, volunteers, agents and assigns, harmless from any fees, penalties, liabilities, claims, losses or damages (including reasonable attorney fees) incurred by SCOR as a result of SCOR's reproduction, transmission, retransmission and/or distribution of the sound recordings and/or musical compositions embodied therein which are identified below in accordance with the terms of this Broadcast Release Agreement or as a result of all other rights granted to SCOR in connection with such sound recordings, musical compositions, trademarks and other intellectual property in accordance with the terms of this agreement.
7. "Owner" further grants SCOR a worldwide, non-exclusive royalty-free license right to reproduce, use, transmit and display, in connection with the transmissions authorized herein, the name of the sound recording and the musical compositions embodied therein, the composers, the performers, and, if provided by or on behalf of the "Owner", the logo of the performers, biographical information, album graphics and photographs of the performers.
8. The authorization granted pursuant to this Broadcast Release Agreement may be revoked at any time by the "Owner", provided that the parties agree that such revocation shall become effective only thirty (30) days after written notice of such revocation is received by SCOR.
9. This Authorization will be governed in accordance with the laws of the state of Kansas, without regard to its conflicts of law principles.
